We may use the following techniques: Rule-based approaches Machine learning algorithms Human-in-the-loop Rule-based approaches are commonly used in practice to solve decision problems, such as "what should I do?" or "is this decision correct?". Our brains are very good at finding patterns and making decisions based on them. In the aforementioned example, our brain may look at the current weather conditions and based on them make a decision. Another example of a rule-based approach is an intelligent routing system that can route the best path to a customer based on his preferences, or how much fuel he needs to use. The approach is very popular in practice because it is easy to build and very fast, while giving high accuracy. However, these approaches do not scale. Typically, the more rules there are, the harder it is to predict the outcome (due to "overfitting") and the more limited your rules become. Machine learning algorithms are a very popular way to solve certain decision-making problems. In practice, these algorithms are used to learn the decision rules that we have written ourselves, like the one that we showed above. These algorithms are very powerful and can be used to learn from vast datasets with little to no supervision. However, they are very complex and difficult to implement. They are often used to detect features that we cannot describe in a well-defined rule (like a customer's interest or a customer's preference). In these cases, people often use human-in-the-loop approaches. Human-in-the-loop approaches are very popular, because they are easy to implement and can be very useful. However, the quality of the outcome strongly depends on the person making the decision. Typically, experts are used in these cases. In the case of using Q-learning, human-in-the-loop is very important, because we need to find some form of reward that represents the number of potential customers that will buy your product. If you ask a machine-learning algorithm to choose from a set of potential rewards and then ask the same algorithm to choose from the set, you will not get the same results. As a result, when dealing with business decisions, it is good to involve a human expert to make sure that you are making the best decision
