Performing miracles with vector artwork When we talk about getting started with Photoshop, we mean that a beginner can use it to edit and manipulate images, and that's exactly what the program does. However, even the first thing a beginner can do is take the time to learn about the tools available and about how the tools work. Vector art refers to a type of artwork in which you have already mastered a layerbased system (see Book III Chapter 1) and know how to manipulate your artwork. A vector image is one in which all elements are the same shape and dimension. This also means that you can resize or edit an image without it changing. Think about it like this: say you are creating a computer game or animated film. You have a character that has a face and a body, but you can alter the size, shape, and positioning of the body or face without altering the other elements. The rules of design are very similar to the rules of mathematics, in that you can use any method or system or algorithm to create an image that makes sense. Photoshop includes the means to create vector-based images using Illustrator, the industry standard for vector illustrations. To create a vector image, you must create a path that you then convert into a shape. Unfortunately, when converting an image to a vector shape, not every possible image is a vector image. You can have a PNG or JPG image with a layer mask applied to it, and when you convert the image to a vector file, you can find that you've lost all the details. A PNG file allows you to retain the image's original quality, as well as retain its transparency, which lets you see the image through the masking over it. When working with transparency, it's important to

(g)The court may impose a reasonable condition of probation or supervised release that such other condition or requirement is reasonably related to the sentencing factors set forth in section 3553(a) and reasonably necessary to fulfill the conditions set forth in section 3553(a)(1), (a)(2)(B), (a)(2)(C), and (a)(2)(D), and to assist in the determination of the sentence to be imposed in the case. Commentary Subsection (d) specifies the minimum and maximum terms of imprisonment authorized for the offense. Subsection (e) provides that the district court shall provide the clerk of the court with notice of the court's imposition of a sentence of restitution in cases in which that sentence is imposed.
